INSTRUCTIONS FOR ABSENTEE BALLOT APPLICATION

- 1. All applicants for absentee ballots shall fill out the application on the front side of this form and sign it. A separate application must be submitted by each person applying for an absentee ballot.
- 2. All absentee ballot applications must be received by the district clerk at least seven (7) days before the vote if the ballot is to be mailed to the voter, or the day before the vote if the ballot is to be delivered personally to the voter at the District Offices.
- 3. Where a person is or would be, if he were a qualified voter, entitled to apply for the right to vote by absentee ballot under the provisions of this Section, his spouse, child or parent, if a qualified voter and a resident of the same school district, shall be entitled to vote as an absentee voter upon personally making and signing an absentee ballot application showing that he expects to be absent from the school district on the day of the school district vote by reason of accompanying or being with the spouse, child or parent who is or would be, if he were a qualified voter, so entitled to apply for the right to vote by absentee ballot, and, in the event no application is made by such spouse, child or parent, such further information as the Board of Education shall require.
